Invitation for 'Expressions of Interest' for Warehouse Construction at Muara Supply Base

Brunei Shell Petroleum Co. Sdn Bhd (BSP) is seeking Expressions of Interest (EoI) from companies for the construction of a 14,000 m2 warehouse with office facilities at its Muara Supply Base.

Tender Scope:

The proposed warehouse shall either be based on conventional civil construction methodology or prefabrication type. Where pre-fabrication type is preferred by BSP (to be finalised at tender release), awarded contractor shall engaged a pre-fabrication vendor (certified products) in the market or any BSP nominated vendor. The warehouse is to be completed by Q4'2024 and hence shall be a fast-track contract.

Scope of contract shall include;

- Construction and installation of the pre-fabricated warehouse including but not limited to the designs for brownfield and greenfield works (+ABCi approvals)
- Provision of all resources i.e personnel, equipment, tools, materials etcs for the construction and installation including mobilization of pre-fabrication vendor representatives for installation supervision.
- Occupation permit from ABCi


