Invitation for 'Expressions of Interest' for Provision of Café Services

Brunei LNG Sdn Bhd is seeking Expressions of Interest (EoI) from companies for Provision of Café Services.

Tender Scope(s):

The CONTRACTOR shall provide personnel, material and equipment for the operation of Café Services at BLNG Facilities. The scope shall include but not limited to provide fresh and light meals, hot and cold drinks, and healthy food and drinks options. The food ranges from fresh bakes and freshly cooked a la carte meals to deli style to subs to other kinds of sandwiches.

Café provider shall design and construct at its own cost a "plug-and-go" concept café with its own characteristic at designated location(s) provided by BLNG, with your own:

- a. Kitchen equipment and appliances
- b. Kitchen utensils and accessories
- c. Table wares i.e. plates, bowl, server wares, eco-friendly cutleries, etc.
- d. Basic furniture i.e. tables and chairs

Live cooking shall be allowed at the BLNG provided facilities.

The scope also includes Supply and Delivery of Fruits, Light Snacks, Coffee Beans, Tea and other consumables to Brunei LNG's site and/or designated site(s).
