Brunei LNG Sdn Bhd is seeking Expressions of Interest (EoI) from companies for the **Provision of Shift Operations** Maintenance Personnel & Moorers for Brunei LNG (BLNG)

#### Scope of Work:

The scope of work shall include but not limited to the following:

- 1. To provide personnel to support coverage for all assets, day and night shifts i.e. housekeeping & day to day operation.
- 2. To provide suitable and qualified Personnel, who are capable of carrying out the mooring & unmooring operations of the LNG tankers and operate the associated mooring equipment including the facilities at the Brunei LNG Offshore Loading Jetty. Personnel shall be ready and able to pilot the railcar for safe transportation of personnel and equipment to and from Offshore Loading Jetty.

#### Local Business Development (LBD)

Brunei Shell Joint Venture (BSJV) Companies' LBD requirements are in line with the LBD Directives as issued by the Department of Energy. As part of the In-Country Value (ICV) initiative, this scope falls under the **Core** Quadrant of the LBD framework. This EoI has the following criteria:
