Invitation for 'Expressions of Interest' for PROVISION OF X-RAY MACHINE & ASSOCIATED SERVICES

Brunei Shell Petroleum Co. Sdn Bhd (COMPANY) is seeking Expressions of Interest (EoI) from companies for the **PROVISION OF X-RAY MACHINE & ASSOCIATED SERVICES.**

Tender Scope:

The scope includes but not limited to:

- Provision, installation and lease of a new medical x-ray machine to be installed at Panaga Health for the purpose of taking digital x-ray images which have the potential to be uploaded directly to Panaga Health's electronic patient information system.
- Provide preventive maintenance and ad-hoc remedial maintenance of the medical x-ray machine listed above, the COMPANY's Ultrasound Equipment and Direct view Classic CR Single-Cassette Reader System. The preventive maintenance shall include but not limited to calibrating, adjusting, cleaning, inspecting and testing procedures designed to reduce product failure and/or extend useful life of the equipment as per manufacturer instructions.
- Quality assurance tests shall be implemented alongside with the preventive maintenance with the X-ray unit, such tests are to assess on tube filtration, consistency/reproducibility of radiation output, consistency of exposure factors settings, focal spot size, accuracy of collimation of Light Beam Diaphragm and x-ray beam alignment.
- Remedial maintenance is to be undertaken on and as when necessarily basis and shall include diagnosis and correction of equipment malfunctions and failures. The remedial maintenance request shall be acted upon within 24 hours of notification for local source and maximum of 72 hours for foreign source.
- Provide safety inspection on the electrical, mechanical and radiation protection aspects on all radiography equipments and their accessories. The work also covers inspection on the walls of the X-Ray rooms and conditions of the film processing rooms.
- Supply of spare parts and X-Ray film on Direct view Classic CR Single-Cassette Reader System.
- Supply of Medical Consumables
- Provision of Comprehensive Radiation Monitoring Services
- The safe removal and disposal of Panaga Health's existing medical x-ray machine.
