Scope of Work:

Brunei Shell Petroleum Co. Sdn Bhd requires continuous hire of skip loader services to support waste management operations across multiple locations within Brunei. This includes pick-up and transportation of waste skips between BSJV's facilities in Muara, Tungku, Gadong, Berakas, and Batu Panggal (Brunei-Muara district) and other facilities located in Telisai, Lumut, Seria oilfields, Rasau, Asam Paya, company offices, and warehousing facilities in Kuala Belait.
