#### Invitation for 'Expressions of Interest' for the Provision of Telecommunication Services

#### General Tender Scope:

The Contractor shall be required to provide the necessary personnel, equipment, materials, tools and suitable vehicles to fulfil the scope of work and shall be in compliance with BSP HSSE Standards. From time to time, project-based scope on call-off basis will be requested whenever required.

#### Tender Scope 1 – Telecommunication Services:

Provision of services for maintenance and installation of data communication, radio communication, and Public Address System (PAS), CCTV at hydrocarbon area, in BSP operating areas onshore from Rasau, offices at KB to Muara and offshore locations including production platforms, drilling rigs, vessels, workboats and barges.

Restoration and maintenance (preventive and corrective maintenance) of BSP Telecom Towers (onshore and offshore), inclusive of related services and products such as lighting system, antenna, lightning arrestor, lightning protection systems, anti-fall systems, grounding system, painting, erect/dismantling tower structure, radio cabling, etc.

- 1. Supply of remote telemetry units' parts and data radio for Remote Telemetry Unit (RTU) for onshore and offshore.
