Invitation for 'Expressions of Interest' for 000419/DOP – Provision of Mechanical Cleaning for Waxy and Scaled Lines Onshore

Brunei Shell Petroleum Co. Sdn Bhd is seeking Expressions of Interest (EoI) from companies for the 000419/DOP – Provision of Mechanical Cleaning for Waxy and Scaled Lines Onshore.

Scope:

Objective of the work is to remove wax and scale inside the flowlines, pipelines and well tubings by performing solvent soaking and cleaning.

Detailed scope of work includes, but not limited to:

- a. Provision of Manpower, Tools and Equipment.
- b. Site preparation and equipment set-up for cleaning activities
- c. Hook up wax and scale removal equipment with COMPANY's above mentioned assets, after COMPANY isolate these system and hand over the same to contractor.
- d. Pre/post cleaning using borescope to verify cleanness pipe internal.
- e. Cleaning and dewaxing of lines using mechanical cleaning in the forms of hydro-jetting or any other technology that can execute the job safely
- f. Post cleaning flushing to remove loosened debris until water is running clear.
- g. Hydrotest of carbon steel, duplex stainless steel and RTP Lines. RTP is non-metallic lines.
- h. Collection of waste from pipe internal. Disposal by COMPANY.
- i. Separation of solid debris and oily wastewater.

Background:

Brunei Shell has been implementing this scope since 2015 by collaborating with a business partner as part of DARAT wax and scale management. The method/practise mentioned below is the ongoing practise and the following information is served to give potential bidders the ongoing method to remove the wax and scale in COMPANY's facilities. Bidders can propose other method as describe under 'Alternative Technology' below.

The scope is removing the wax inside well downhole tubing and removing the wax/scale in the flow lines. In removing the wax from inside well downhole tubing, solvent is injected using a pneumatic pump. For flowline/pipeline dewaxing, the business partner used mechanical equipment to push the wax out of flowline up to 1000m distance. Borescope equipment, capable to access 120m distance, is used before and after the cleaning to verify cleanliness of pipe internal as well as the effectiveness of the cleaning method. Similarly applied to de scaling of pipeline but chemical is used to dissolve the scale and use mechanical cleaning tool to ensure the internal is free from scale deposit. The pipe diameters vary from 50mm to 250mm.

Some typical equipment used are;

- Injection pump that inject solvent up to 10bar and used for hydrotesting of pipeline.
- ii. Hydro-jetting equipment with mechanical tools that can travel inside pipeline up to 1000m.
- iii. Air compressor.

Alternative Technology.

Contractor can submit a proposal of new method/technology which is different from the method as described above. Company is interested in new method/technology that provides lower cost, lower impact to production deferment and effective in removing wax and scale. Please take note that, the water cut in some wells can be as high as 90% which can impact effectiveness of chemical/solvent. For new method/technology, company would request field trial to prove successful implementation based on 'No cure no pay' and contractor will be paid upon successful trial. Terms and conditions to be agreed by both parties prior to field trial.

For this EOI, interested vendors are required to answer the questionnaires listed in Appendix A and submit them as part of the EOI submission. Failure to submit the questionnaires may result in disqualification for BSP EOI evaluation.
