Invitation for 'Expressions of Interest' for Provision of Underwater Pipeline Cathodic Protection Survey

Brunei Shell Petroleum Co. Sdn Bhd is seeking Expressions of Interest (EoI) from Companies for the **Provision of Underwater Pipeline Cathodic Protection Survey.**

Tender Scope:

There are several hundreds of subsea pipelines in BSP facilities, all equipped with cathodic protection system (sacrificial anode, impressed current, bonded to jacket, etc) as secondary barrier against external corrosion. Amongst BSP pipeline inventory, there are a number of pipelines identified per asset which require "Underwater Pipeline Cathodic Protection survey", which is a 5 yearly preventive maintenance for subsea pipelines to verify whether the whole pipeline is adequately protected by the cathodic protection to mitigate external corrosion.

The scope of work shall include, but not be limited to, the following:

- 1) The CONTRACTOR shall be responsible for performing the "Underwater Pipeline Cathodic Protection Survey" for offshore subsea pipelines.
- 2) Supply of vessel, equipment and materials required to perform the survey.
- 3) Supply of qualified personnel (NACE certified or equivalent) to conduct the survey, with technical/specialist team to support in troubleshooting where required during the execution.
- 4) Provide personnel for activity planning and logistic arrangement for the intended scope.
- 5) Perform the necessary setting up and testing of the system (vessel, equipment, software, etc) prior to mobilization to offshore and the start of each activity. This includes visual inspection of the system checking the overall setup, cabling, cleanliness, presence of all components/equipment and their layout, accessibility, etc. Functional check of the system shall also be performed.
- 6) Provide all utilities, labour, test equipment and consumables required to perform the test. Any problems encountered shall be clearly indicated, highlighted to the COMPANY and the problem shall be rectified.
- 7) Deliver a report summarizing the survey finding, analysis outcome and recommendation for remedial action (if any).
