### General Description of BSP & BLNG Facilities and assets

#### BSP:

209 offshore platforms and 123 onshore location for topside static equipment consisting of piping, pressure vessels, heat exchangers and above water structure.

#### BLNG:

5 LNG production Trains, 2 Refrigerant Make Up units, Compression Plant, Terminal and Utilities, Static equipment consisting of piping, pressure vessels, heat exchangers, tanks, pipelines, slug cathers, pig launchers, boilers and flare.
