### Invitation for 'Expressions of Interest' for Landscape, Horticulture, Gardening & Grass Cutting Services for Brunei LNG

Brunei LNG Sdn Bhd is seeking Expressions of Interest (EoI) from companies for the Landscape, Horticulture, Gardening & Grass Cutting Services for Brunei LNG.

#### Tender Scope:

- 1. Grass cutting including weeding and spraying.
- 2. Horticulture work carrying out agricultural practices, planting of new plants including replacing, conserving and re-vegetating plants.
- 3. Maintenances work trimming of plants and shrubs, watering plants, tree cutting including trimming and trunk removal.
- 4. The supply and delivery of red bricks, top soil, fertilizers and chemicals (herbicides/weedicides and insecticides) including transportation to Brunei LNG site as requested.
- 5. The provision of short term hire of potted plants as and when requested by Brunei LNG.
- 6. To provide the necessary equipment and materials for work to be carried out (grass cutting back pack, tractor, chainsaw, gardening tools including transportation of personnel).
- 7. Landscaping work as and when required by Brunei LNG.
- 8. To comply to BSJV standards and procedures in Health, Safety, Security and Environment (HSSE) including quality and the requirements of the relevant authorities.
- 9. Worksites may include:
  - a) Company's Plant (within and outside restrictive area, surroundings i.e. parking sites, all access roads to worksites)
  - b) Asset Rejuvenation Project (ARP) warehouse compound, Fire Fighting training ground
  - c) Onshore Compressor Plant (OCP) site
  - d) Masjid Zainab and its surroundings
  - e) Badas Track
  - f) Liang Lumut Recreation Club (LLRC) (including access road LLRC-Brunei LNG)
  - g) Propane Bottling Plant site
