Invitation for 'Expressions of Interest' (EOI) for Provision of Industrial Building Demolitions Services

Brunei Shell Petroleum Co. Sdn Bhd (BSP) is seeking Expressions of Interest (EoI) from companies for **Provision of Industrial Building Demolitions Services**.

1. Background

As part of BSP's ongoing commitment to optimize utilization of existing assets, BSP is actively exploring opportunities to maximize the current asset occupancies while removing the assets that are deemed underused or unsafe to operate. To achieve the above objective, BSP is interested in vendors who are highly competitive in delivering safe industrial building demolitions which are non-hydrocarbon based.

2. Tender Scope

The scope of work includes routine and non-routine estate maintenance services and shall include but not limited to, the provision of personnel, equipment, materials, consumables and logistics, including necessary vehicles for access such as, but not limited to, cherry picker/skymaster and grass cutting tractor to carry out the following tasks:

- i. Mobilisation to Site, Clearing Site and Setup Hoarding Boundaries;
- ii. Asbestos Containing Materials (ACM) Safe Handling and Removal (where required);
- iii. Earthwork, Excavation and Ground Leveling;
- iv. Demolition of Building Structure;
- v. Reinstatement of Demolition Area; and
- vi. Disposal of Waste Material.
