## Tender Scope:

The scope of services to be provided by CONTRACTOR for BSP hydrocarbon facilities shall include but not limited to the following:

- a. Provision of labour, services, tools, equipment, logistics, workshop facilities and materials, required to carry out all maintenance services of EDS (HV and LV) from 66kV Overhead Transmission Line to 415V distribution pillars units, and building distribution boards.
- b. The work activity also extended to cover instrumentation maintenance for offices, domestic, industrial and welfare building complexes.
- c. Preventive maintenance and corrective maintenance of COMPANY electrical and instrumentation equipment.
- d. Call-off/ad-hoc work associated to electrical and instrumentation equipment.
- e. Rental of equipment to COMPANY when requested by the COMPANY.
