EOI Title: Muara Fire Fighting Upgrade - Construction

Background

Brunei Shell Marketing (BSM) is currently looking into an opportunity for Muara Fire Fighting Upgrade - Construction. Purpose of this EOI is to explore new approaches & available partners capable of providing the fabrication and installation services.

The existing Fire Fighting system in Brunei Shell Marketing (BSM) Terminal located in Muara is planned for an upgrade. The upgrade will be mainly focused in the tank farm area, and includes the following:

- Upgrade of Firewater line from DN200 to DN250
- Replacement of the current 2 Way hydrant to 4 Way hydrant (Remove old & Install new)
- Replacement of the existing sprinkler system (Remove old & Install new)
- Installation of Equipment

The scope of work will be done in phases and shall include and but not be limited to:

- Supply of materials as stipulated in Material Take Off (MTO) as provided, including storage of equipment during project duration
- Constructions, fabrication, and installation as per approved AFC drawing package.
- Installation of Equipments i.e. Jockey Pump, Foam Monitor, Foam Maker, Nozzle and Sprinkler.
- Installation and removal of electrical cable, PACO instrumentation.
- Waste Management, including chemical wastes, etc.

The outcome of this EOI is to release a selective Request for Quotation (RFQ) and initiate a Project to implement the proposed solution.

4. **Health, Safety, and Environmental Policies:** Provide information about your company's policies and procedures regarding health, safety, and environmental management. Emphasize your commitment to maintaining a safe work environment and minimizing environmental impact.
5. **Quality Assurance and Control:** Explain how you ensure quality throughout the construction process, including any quality assurance measures or quality control protocols you have in place.

6. **Materials storage and Fabrication Shop** – To supply details of its intended or existing facilities which are proposed to be utilised in connection with the proposed contract.
7. **Contact Information:** To include contact information.
