#### Invitation for 'Expressions of Interest' for Provision of Scaffolding and Access Services

Brunei Shell Petroleum Co. Sdn Bhd is seeking Expressions of Interest (EoI) from companies for the **Provision of Scaffolding and Access Services**.

### **Tender Scope:**

The scope comprises the provision of scaffolding and associated access, including but not limited to supply, engineering drawings (as and when required), installing, erection, alteration, modification, subsequent dismantling, store and back load of scaffolding including the required inspection and certification of safe for use as and when requested by the COMPANY. Necessary to meet the COMPANY's requirements for temporary working platforms and other such structures associated with the COMPANY's offshore activities. This shall include but shall not be limited to scaffolding inside and outside of equipment in the process area and the COMPANY's offshore facilities. The scope will be carried out either by day tripping onshore-based personnel, personnel offshore as and when required or by offshore resident personnel.

### **Company Criteria:**

Contractors interested in participating in this Tender are to pay particular attention to the following Company Criteria:

- 1. Contractor capabilities and experience
  - a. Contractor must have at least minimum 3 years of experience on scaffolding in any industrial facilities (Oil and Gas or Chemicals) and not limited to onshore or offshore work in the last 7 years.
- 2. Contractors must possess the following accreditations following within 1 year of Award
  - a. ISO 9001:2015 Quality Management System.
- 3. The following a few of the key capabilities the BSP will be assessing as part of the Tender:
  - a. Experienced in providing Scaffolding (and/or Access) services and are registered Scaffolding provider in GEP system with sufficient volume scaffolding materials or equivalent.
  - b. Ability to manage >100 competent offshore and onshore personnel.
  - Personnel has the capability to do scaffolding and/or access calculation or engineering as and when required.
  - d. Capability of providing storage yard to store scaffolding and/or access materials, fire department approved hazardous storage facility, office building with complete training rooms, meeting rooms and site training facility.
  - e. A member of IRATA (Rope Access trade Association, UK)
  - f. Ability to support multi-skilling personnel capability
