### <u>Invitation for 'Expressions of Interest' for 000294 - Provision of Composite Wrapping Services</u>

Brunei Shell Petroleum Co. Sdn Bhd (BSP hereinafter) wishes to invite and identify technically capable vendors for a tentative tender for the **Provision of Composite Wrapping services.** For this purpose, a technical pre-qualification will be performed based on your response and submission of required information.

<u>Note:</u> Interested Vendor(s) are kindly advised to peruse this EOI and all the appendices. Please follow the instructions given in making the response and submission.

#### Scope of work:

Objective of the work is to repair and restore the integrity of pipework systems by carrying out composite wrapping activities.

The scope of work includes but not limited to the following:

- 1. The Vendor shall provide the necessary provision of service to perform composite wrapping i.e. manpower and surface preparation including all necessary equipment to conduct the task.
  - Removal of existing coating and installation of a composite wrap, restoring the integrity to the respective piping or pipeline. This will be in accordance with ASME PCC 2 requirements and Company Maintenance Management Procedure (MMP).
- 2. The Vendor shall provide sufficient manpower, equipment, materials and consumables to meet the demand outlined by Company. In addition, the VENDOR shall provide a competent Technical engineer, who shall be based in Brunei, responsible for design calculation inspection and QA/QC checks on any repairs.
  - a) Provision of materials and consumables to restore the integrity of piping and pipeline. The materials should be as stipulated within MMP and minimum stocks will be established to ensure material availability.
  - b) Vendor's warranty for service applies to all defects arising within the contract duration and it is the Vendor's responsibility to ensure that all the composite wrapping repair is in compliance to the code ASME PCC 2 requirement.
  - c) The Vendor shall submit the method statement to the Company for review and approval prior to the actual execution of scope.
    - i) Each method statement shall describe the procedures including installation, risk assessment, QA/QC inspection, testing and reporting to be carried out prior to, during and after repair system application.
    - ii) Unless instructed by the Company, Vendor shall carry out the specific surface preparations as per ASME PCC2. Staff shall be certified with ASME PCC2 and familiar with ISO TS 24817 requirements.

- d) The Vendor shall prepare close-out reports and all essential supporting technical documents that include pre-requirement data sheets; engineering calculations; surface preparation methods and tools used; QA/QC checks sheets and acceptance records; shore hardness test records; and photo record sheets showing prior to, during and after repair installation stages.
- e) The provision of shore hardness test reports is required as per ISO TS 24817 and it will be required for all wrapping performed.
- f) Vendor shall conduct periodic inspections on completed repairs at the discretion of the COMPANY within the warranty period with minimum Industry standards.

#### Minimum Technical Capability Required

Vendors interested in participating in this Tender are to pay particular attention to the following Company Criteria:

- 1. Vendor capabilities and experience
  - a) Vendor and/or Technical partner must have 5 years of experience in composite wrapping in Oil and Gas industries
  - b) Vendor and/or Technical partner able to demonstrate the experience working with any of the composite wrapping as listed below and indicate examples within oil and gas operating companies where it has been applied.

    - c. ClockSpring
    - d. TDW
    - e. Fertek.

    - g. HydroWrap
  - c) Ability to manage > 20 and ≤ 50 competent staff to carry work on shore and offshore and work on normal daily basis and shift pattern (shift pattern or as when required)
- 2. Quality Standard:

The Vendor and/or the Technical Partner must be certified with ISO 9001 standard or equivalent
