Provision of Canteen Services

The CONTRACTOR shall provide personnel, material, consumables and equipment for the operation of on-site Canteen Services to Brunei LNG's staff and other contractors, including provision of Food and Beverages services on ad-hoc basis for packed meal(s) or buffet style, with food delivery services to Brunei LNG's site and/or designated site(s). The scope shall include but not limited to provision of a variety of cuisines with menu planning, hot and cold drinks, healthy food and beverages options, cutleries and food and drink appliances, as required.

Provision of Food and Beverages Services for BLNG Daily Shift Personnel

The CONTRACTOR shall provide personnel, material, consumables and equipment for the operation of round the clock Food and Beverage Services to Brunei LNG's daily shift staff and/or other contractors, with food delivery services for STL-approved transportation (including certified driver) of Food and Beverages to Brunei LNG's site and/or designated site(s). The scope shall include but not limited to provision of a variety of cuisines with menu planning, hot and cold drinks, healthy food and beverages options, cutleries and food and drink appliances, as required, and supply, install and delivery of drinking water including the water dispensers and its maintenance.
