- Provision of security surveillance and protection services for BLNG personnel, facilities, assets, and operations.
- Maintenance of a safe and secure working environment through access control, security monitoring, patrol services, and incident response.
- Management and provision of security logistics and infrastructure, including security huts, barriers, signage, and other associated security equipment.
- Provision of competent, trained, and adequately resourced security personnel to support operational requirements.
- Compliance with all applicable BLNG and Shell Health, Safety, Security and Environment (HSSE) standards, procedures, and requirements.
- Compliance with all relevant statutory, regulatory, licensing, and authority requirements.
- Implementation of effective security management, reporting, and performance monitoring systems to ensure continuous improvement and service excellence.
- Demonstration of the necessary competency, capability, and capacity to deliver the services safely, efficiently, and effectively throughout the contract duration.
