### Invitation for 'Expressions of Interest' for PROVISION OF OFFSHORE RELIEF MEDIC & MEDICAL DOCTOR

Brunei Shell Petroleum Co. Sdn Bhd (COMPANY) is seeking Expressions of Interest (EoI) from companies for the **PROVISION OF OFFSHORE RELIEF MEDIC & MEDICAL DOCTOR.** 

#### **Tender Scope:**

The provision of offshore relief medic & medical doctor at Panaga Health. The assigned offshore relief medic shall adopt Panaga Health medic guiding principles for management and responding to cases seen at offshore and the assigned medical doctor shall adopt Panaga Health protocol.

The Offshore Relief Medic shall carry out but not limited to the following:

- 1) Medical emergency response, stabilization and care for medical and trauma cases, initial emergency responses, resuscitation and stabilisation of critically ill/injured (trauma) patients including applying Basic Life Support (BLS) and International Trauma Life Support (ITLS) Principles.
- 2) Full clinic administration including an initial clinic audit of equipment and medicines, and on-going medical inventory management.
- 3) Perform Fitness to Work screening medicals for BSP offshore personnel at assigned manned platforms.
- 4) Conducting on-site education health promotion activities.
- 5) On-site clinical reporting documentation, activity logs and confidential patient medical record keeping associated with the required activities.
- 6) Management of equipment maintenance/calibration requirements.
- 7) Administrative duties as required under the direction of COMPANY (when practical) and when, in the opnion of CONTRACTOR, does not interfere with the delivery of medical services.

The Medical Doctor (General Practitioner) shall carry out but not limited to the following:

- 1) Provide high quality, primary health care services to the community, patients of all age ranges and keeping with best practice standards.
- 2) Respond to medical/heath problems presented by patients including history taking, diagnosis, investigation, treatment and referral as appropriate.
- 3) Perform medical assessments for occupational health and responding to medical emergencies at Panaga Health or BSP locations as required.
- 4) Provide after hours on call services including medical cover for events as required.
- 5) Provide medical advice and support to other BSP locations and decision on transport to an appropriate medical facility.
- 6) Conduct minor medical procedures as appropriate to a primary health care practice.
- 7) Provide appropriate health promotion and preventative health care advice to patients and supporting in health promoting and screening activities to the Community.
- 8) Assist Clinical Lead in developing and reviewing of procedures and work instructions for Panaga Health
- 9) To participate in improvement activites to the clinic, including conducting clinical audits.
- 10) Support and contribute to the Continuous Professional Development (CPD) committee to conduct CPD activities which contribute to the development and maintenance of clinical competencies.
