Invitation for 'Expression of Interest" - BLNG Office Support Services

The scope shall include, but not limited to, the following services:

- 1. Cleaning services for BLNG offices within both non-restricted and restricted areas (such as LPG Plant, Clinic and Fire Station).
- 2. Cleaning services for BLNG toilets within both non-restricted and restricted areas.
- 3. Collection and disposal of rubbish within non-restricted areas, including parking lots and along the roadside leading to Liquefied Petroleum Gas (LPG) Plant and Fire Fighting Ground.
- 4. Cleaning of windows at height at the Management Building, Block A offices, and the Aerobridge.
- 5. Provision of general helpers to support office moves and cleaning campaigns.
- 6. Provision of cleaning materials, consumables and its associated services for all BLNG facilities, including but not limited to both interior and exterior of buildings.
- 7. Provision of laundry services for coveralls and any other personal protective equipment (PPE), including collection, cleaning and delivery as required.
