Invitation for 'Expressions of Interest' for (i) Provision of Light Vehicle Services, (ii) Provision of Heavy Goods Vehicle (iii) Provision of Heavy Goods Vehicle – Call-Off

Brunei Shell Petroleum Co. Sdn Bhd is seeking Expressions of Interest (Eoi) for the following services:-

1. Provision of Light Vehicles and Services

Brunei Shell Petroleum Co. Sdn Bhd and Brunei LNG Sdn Bhd provide vehicles to cover personnel movement for multitude of on-shore activities, of various Company facilities within Brunei. This also include bus services for crew changes in LNG Lumut, X26, Anduki and Kuala Belait port terminals. The scope also provides chauffeur services for business-related trips to Brunei International Airport, various Ministries, etc.
